Admission and testing requirements:

All dogs from the Verband für Kleine Münsterländer e.V. with a FCI pedigree, which were born after September 30, 2018, and which have passed a Verbandsjugendprüfung (VJP) shall be admitted to the test. *The number of dogs is unlimited.*

For dogs from abroad, corresponding supporting documents are required. Only dogs without breed excluding faults by the registration deadline will be admitted to the test. Testing will be conducted in accordance with the current VZPO of the JGHV.

Handlers/Dogs:

Every handler must be in possession of a valid hunting license and present this at registration. The handler must also verify a valid rabies vaccination for their dog. The dog must be insured.

Game/Firearms:

Live ducks will be provided by the organizer. Handlers are responsible for bringing their own drag game (furred and feathered). To test gun stability at the water, each handler must bring a dead duck. For the field and water work, firearms and ammunition can be made available.

Other:

All participants will receive detailed information material when registering (Thursday, from 2 p.m.) in the test hotel. Packed lunches for the judges, dog handlers and helpers will be provided free of charge on the day of the test. The award ceremony and issuing of test scores and certificates will take place on Saturday evening in a festive setting.

Judges:

Each Landesgruppe is to provide a judge at their own cost or assume the costs for a judge. Each Verbandsrichter must be in possession of a valid hunting license and be registered as an active judge on the current JGHV list. Judges from abroad must attach a copy of the appropriate verification at registration. If a Landesgruppe can and wants to provide more judges, this is possible and desirable in consultation with the Test Director. Judges must be registered by July 30, 2020.
