Admission Requirements:

For the IMP A, only those dogs that fulfill the breeding requirements in their country of origin by the entry deadline will be admitted to the test.

In the case of the IMP B, dogs will be admitted if no faults that prohibit breeding have been identified by the entry deadline (national breeding approval is not a requirement).

A valid PET passport (international vaccination certificate) with valid rabies vaccination must be provided for each dog. Proof of insurance must also be presented.

Handlers: Each handler must be in possession of a valid hunting license and

carry it with them at the IMP. For foreign guests, firearms and ammunition for the field, forest, and water work will be provided by

the organizer.

For handlers who do not have a German hunting license, shooting

will be carried out by an authorized person.

Carrying and using ammunition containing lead is prohibited by law

in these test areas.

Game: The dog handler must bring drag game for the test.

On request, drag game can be provided by the organizer for a fee if

ordered in advance.

The live duck for the water work is provided solely by the organizer.

Meals: Food will be provided for dog handlers and judges during the test.

Other: All dog handlers will receive a program with the current group

assignments on the day of arrival. The official language is German.
