Test regulations: Judging will be conducted in accordance with the current version of the test regulations for the Lönssuche of the Association for Kleine Münsterländer

Breed Show: Only for dogs participating in the Lönssuche.

Participation in the Breed Show is a requirement for participation in the Lönssuche that follows.

Any faults found at the Breed Show that exclude a dog from breeding will disqualify the dog from participation in the subsequent Lönssuche.

Participation in a Breed Show beforehand or an evaluation by a Breed / Conformation Judge is recommended.

Faults found at the International Breed Show on October 9, 2025, disqualify the dog from further testing at the Lönssuche. Dogs then have the option of running an alternative HZP.

Test Entries: Please use the current version of JGHV Formblatt 1 to enter the Lönssuche.

Entries are to be submitted only through the associated Landesgruppen.

Foreign dogs belonging to a KIM-I member country must register directly with the Test Director.

A copy of the dog's pedigree and all previous test scoresheets (VJP, HZP, VGP VPS) as well as any Breed Show certificates must also be submitted.

When registering on the day of the test, **all** previous test and breed show certificates must be presented.

With the entry form, a photo of the dog as a data file must be submitted.

Please note the following for the photo!

Please take the photo of the dog from the side, all 4 legs should be on the ground.

The head should be carried upright, looking forward, the tail should be visible at the level of the topline.

Bookings in the hotel are only possible by telephone or e-mail.

Admission requirements:

Dogs that are entered in the stud book of the Verband für Kleine Münsterländer e.V. or in the studbook of a KIM-I member country are eligible.

The dog's date of birth must be after October 1, 2023.

Dogs must have passed an Association Youth Test (VJP) and a Fall Breed Test (HZP). Dogs must have achieved at least the predicate "good" (at least 6 points) in all natural ability subjects.

The test scoresheet of the HZP must be presented at registration before the Lönssuche on October 9, 2025, at the latest.

For foreign dogs, the corresponding tests of the KIM-I member country apply.

During all previous tests (VJP/ HZP, VGP, VPS) or any breed show evaluation, no physical and / or faults of temperament that would exclude the dog from breeding may have been found.

A valid PET passport (international vaccination card) with a valid rabies vaccination must be presented for each dog on the day of the test.

Only dogs for which the complete entry and entry fee have been submitted by the entry deadline will be admitted to the test.

Handlers:

Each handler must be in possession of a valid hunting license and carry it with them.

Foreign dog handlers must present a valid hunting license from their home country upon registration.

Foreign dog handlers should ensure that they have insurance cover.

(Possession of insurance coverage is confirmed on Formblatt 1 with the signature).

A valid PET passport (international vaccination certificate) with a valid rabies vaccination must be presented for each dog.

If possible, the duck logbook required by the state of Lower Saxony must be presented on the day of the test.

For handlers who do not have a German hunting license, shooting will be done by an authorized person.

For the field and water work, a shotgun and **only** lead-free ammunition may be used at the test. **Lead shot may not be brought to the test!**

A firearm will be provided for foreign dog handlers on the day of the test.

After the Lönssuche, each dog handler will receive certificates for the Lönssuche, the HZP, and the Breed Show for the dog they handled.

Game: The dog handler must bring drag game for the test.
On request, drag game can be provided by the organizer for a fee if ordered in advance.
The live duck for the water work is provided solely by the organizer.

Meals: Food will be provided for dog handlers and judges during the test.

Other: All dog handlers will receive a program with the current group assignments on the evening before the test.
The official language is German.

The test regulations for the Lönssuche can be downloaded from the website. Judging will be done based on the VZPO of the JGHV (2017 version) with the additions for the Lönssuche in accordance with the current version of the Lönssuche Test Regulations.
